**Subject: One day 'Dharna' in Ramleela Maidan, New Delhi on 17-11-2017 at 1000 hrs.**

Dear Brothers & Sister,

It is hoped that all of you are well and busy in accelerating trade unions activities. You are aware of that Bharatiya Mazdoor Sangh invoked a one day Dharna on 17 November 2017 in Ramleela Maidan, New Delhi against Anti-Labour and Anti-Industrial policy of the Government. Being an industrial unit of BMS this federation has to participate with massive number of its members. As all of you are aware that of late the Govt has initiated many policies which has been affecting adversely the vast class of society; proletariat and started to change legislation related to Labour, Safety, Social Security etc without any consultation to the representatives of that class. As far as BMS opinion is concerned, it wants reformation in current legislations so that it may be more fruitful to the deprived class of society.

Further, it is worth to mention here that as far as defence civilian employees and defence industries (Govt Sector) are concerned, the major changes made by Govt are not in favour of concerned employees. Most of changes like Closure of 39 Military Farms, Non-core items of OFB, Disbandment of EME workshops/ Ordnance Depots/ ASCs, encouraging manning contracts ignoring existing Manpower, outsourcing in DRDO, Air force and Naval establishments, change of nature of production of OEF group of factories from stitching to ammunition manufacturing proved a nightmare to lower rung employees of the establishments. All the changes have been made with feudal mindset without considering socio-economic and national importance of these establishments. On the other hand anomalies/ grievances like the matter of enhancement of Minimum Pay and Fitment factor, unflagging of several Allowances of 7th CPC are still unresolved.

It is time to raise our voices against these exploitation and arbitrary decisions made seamlessly by Govt without going through the actual needs.

Therefore, you are requested to participate in the Dharna with massive number of members to make this Dharna grand Success so that Govt may be constrained to ponder again upon its policies. No arrangement with respect to accommodation, transportation and meal will be provided by the Federation. Please make all the arrangements yourselves. Further, you are requested to participate in the Dharna with all your members wearing a batch mentioning BPMS and respective State Name and bring your union banner and flags.
