With due regards, your attention is invited to the remarks of Shri B R Naresh Kumar {Point No. 5.10(d)} in the meeting held on 12.04.2017 wherein he reiterated his demand to frame the transfer policy for IES, NIEs & NGOs of Ord & Ord Equipment Factories. He has earlier demanded (Point No. 6.4 of 21<sup>st</sup> Steering Committee meeting held on 30.03.2017) to settle the issue without delay.

It is worth to mention here that the Federations and Associations have already given a joint draft transfer policy for IEs, NIEs & NGOs and to formulate the transfer policy OFB has constituted the Rajvir Singh Committee which have submitted its recommendations to OFB.

Further, vide DoP&T OM No. 11013/10/2013-Estt.A, Dated 02.07.2015 all the Ministries/Departments have been directed to frame a transfer policy and place in public domain the transfer policy.

In such circumstances, you are requested to resolve this issue without further delay.
